## Paraflyte OSHA Style Lifeguard Chair

Part Number: 20004 (Superflyte)

### **Specifications**

- The lifeguard chair superstructure shall be manufactured of ASTM A-554 certified 1.90" x .145" wall thickness (1) (Ultraflyte) or 1.90" x .065" wall thickness (Superflyte) Type 304 stainless steel polished to a 320 grit finish.
- The main platform decking shall be made of Douglas Fir coated in fiberglass reinforced with a polyester (2)resin. The top surface shall have a white, integral non-skid surface. The overall platform area shall measure 40" x 24".
- The mounting steps shall be made of white, UV stabilized, ABS plastic with an integral, 4" wide non-skid surface. (3) The steps shall fit a 19" post spacing (center to center) and shall be positioned 15° off vertical.
- The fiberglass seat supported on a stainless steel tube structure, shall be capable of a 360 degree swivel (4)and bearing surface shall use a low friction, non-metallic disc to prevent seizing or binding due to corrosion. The seat shall be located at a height of 6'-0" (72") above the pool deck.
- The support pedestal shall be made of ASTM A-554 certified Ø3" x .120" wall thickness T304 stainless steel with (5)1/4" x 6", (4) hole square flanges fully welded to both ends yielding a 15° angle off vertical. The pedestal shall be polished to a 320 grit finish.
- The rear posts of the superstructure shall be mounted in to bronze wedge anchor sockets, which shall be fully (6) embedded in a concrete deck. Escutcheon plates shall be provided for each post.
- The support pedestal shall be anchored via a stainless steel anchor assembly which shall be fully embedded in a (7)concrete deck. The pedestal shall be attached to the anchor using (4) Ø1/2" stainless steel hex head bolts. A bond screw shall be provided.
- The lifequard chair shall be provided with an umbrella ring guide, attached to the superstructure, and umbrella (8)base/life ring holder, attached to the fiberglass decking, as a means to attach an umbrella to the lifeguard chair.

#### General

The stainless steel frame shall be electro-chemically passivated on all worked areas for maximum corrosion resistance. All hardware shall be 18-8 stainless steel. Custom designs and modifications are available upon request.
